A(vi) Diamantina Shire Council Natural Hazard Management Area (Flood) and Defined Flood Levels

Executive Summary

The Queensland Development Code sets mandatory requirements for "finished floor levels", based on "defined flood levels" within a "flood hazard area". Whilst there is no formal statutory obligation on Council to designate a flood hazard area and floor levels, adequate and appropriate controls can only be effectively applied within a relevant framework of flood parameters adopted by Council. Council can by resolution designate a "natural hazard management area" and the associated "defined flood levels" and "finished floor levels". In so doing, such designated levels become mandatory building requirements, particularly for Class 1 buildings (houses).

That Council defer making a decision regarding setting defined flood levels to allow for additional clarification of flood levels in Birdsville and Bedourie during the 1974 flood levels to be undertaken by the consulting engineer.
