EXECUTIVE SUMMARY

A lessee has requested a payment arrangement for annual lease payments because of significant financial impacts from the 2025 flood event. The request does not change the total lease payable but alters the timing of cash receipts to Council. This report presents options for Council to either approve the deferral or decline the request.

RECOMMENDATION

That Council:

1. Approve the request to defer the lease payment of \$75,000 plus GST; and

2. Delegate authority under s 257 of the *Local Government Act 2009* to the Chief Executive Officer to execute a payment arrangement under the contractual payment obligations of the lease.

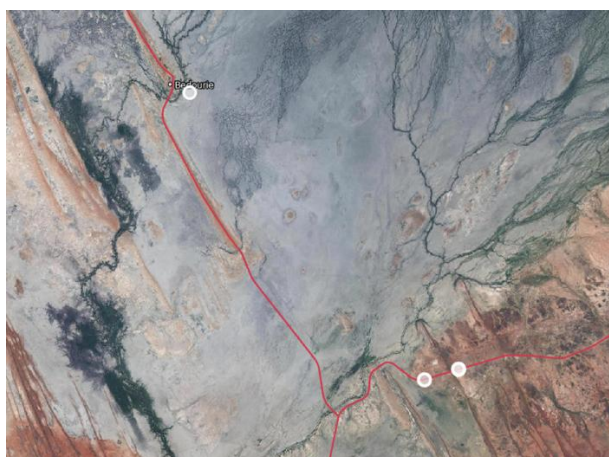

14.2 AMCO Prime Spill

EXECUTIVE SUMMARY

The purpose of this report is to review an incident that occurred in December 2025 relating to a bitumen spraying contractor. Queensland Central Bitumen (QCB) completed bitumen spraying works to the Cuttaburra 1 section recently completed. As part of these works QCB had some left over AMCO Prime in their spray tank. The contractor discharged this bitumen product on at least three sites following the works. Two of the three sites were stockpile pads adjacent to the road which had previously stored precoated aggregate and premix asphalt among other bituminous products. One of the sites was a private unsealed road, south of Bedourie.
